1. About CIE

CIE is a non-profit and independent knowledge centre for international cultural heritage cooperation. We aim to increase collaboration and knowledge sharing in the cultural heritage field by bringing professionals together, collecting and disseminating expertise and developing and facilitating heritage projects all over the world.

In the past three years the main focus of CIE have been research themes and activities related to intangible heritage, maritime landscapes, postcolonial museums, conflict heritage and expanding heritage networks. Many of the projects included or were part of larger educational programs such as: field schools in Tanzania, Sri Lanka and South Africa, educational heritage program for university students, training capacity building programs for heritage Professionals etc. Currently we conduct research on multiple locations around the Indian Ocean. Big part of this research is organized in cooperation with New York University in Abu Dhabi. The research activities are organised in relation to the main themes of a broader research focus, which are the history of the European expansion and the pre-European expansion era Arabian trade routes or the maritime trade connections between Asia, Africa, the Middle East and Europe.

The CIE maintains relations with various national and international institutes. A broad academic network is important for the mission of the CIE as expert- and network-organization. The people involved have expertise in the field of restoration, building history, museology, archives and archaeology. Our experts are available for advice, training and consultancies.

1.2 Our Approach

Our work is characterized by a collaborative approach. We uphold a high standard of ethics and working inclusive is our core value. We offer a 'culture-conscious' approach befitting for each different local context. Of some activities the CIE is initiator, of others the CIE joins existing initiatives and contributes through its specific knowledge and know-how. In all cases partnerships are considered essential for any further development and the sustainability of these activities in the future.

1.3 Our network of Affiliated Experts

The strength of the CIE is to bring together different stakeholders and create common understanding. Through knowledge and international cooperation all parties can give meaning and added value to cultural heritage worldwide. Since it's beginning CIE has maintained a worldwide network of heritage professionals and has functioned as a resource centre for the international heritage field. We work together with our partners in building capacity, managing cultural heritage programmes and in sharing know-how and best practices.

Since 2007 the CIE has initiated the platform Cultural Heritage Connections. The platform is now maintained by Dutch Culture and brings together experts, projects, and organizations in the field of international heritage cooperation. The emphasis is on mutual cultural heritage: heritage that is shared between two or more countries. It is a platform for information exchange and a documentation centre for projects. However, although the Cultural Heritage Connections grew into a big platform, it is lacking in interactive features that could engage people. For this reason, in 2014 CIE has taken the initiative to develop a new online platform

– **Heritage Emporium.** The Heritage Emporium is envisioned as an online tool for exchange and interaction as well as a good opportunity for building an audio-visual database of oral stories, photographs, audio material etc. The platform is also meant to improve knowledge exchange between different stakeholders in order to deepen the understanding of heritage sites and many divergent cultural layers that were created through the longstanding contact between multiple regions through shipping, trade and colonialism.

3. Activities (2018-2019)

The nature of the CIE activities has changed in the past three years. The focus has changed from projects related to the Dutch Mutual Program to more internationally oriented projects done in collaboration with other institutions. The cooperation with NYU Abu Dhabi (NYUAD) has been one of the most important. In cooperation with NYUAD several educational programs and workshop have been organized around themes related to evaluation, interpretation and management of heritage sites. The more recent academic character of the CIE activities has opened opportunities for making links between heritage scholars on one side and heritage practitioners and managers on the other.

Heritage sited in Sri Lanka, India, the Middle East (including Afghanistan and Pakistan with their connection to the Silk Route), Zanzibar/Tanzania, Mozambique, and South Africa, have often been denominated World Heritage Sites by UNESCO. On them, we combine historic archaeological research into maritime landscapes with the theory and practice of heritage management. The sites are being studied from a global as well as a local perspective.

The theoretical framework for this research is formed by the concept of landscapes, and the idea of shared versus contested heritage. On the local and regional level we study the historic port or colonial city and on the intra-regional and global level we look at the Indian Ocean as a maritime landscape. Essential to this research project and theme is the large network of local researchers that has been established over the years, and those functions as a pool of professionals and communities which together form a framework from which new practical projects arise.

3.1 Academic Activities:

3.1.1 Training and Teaching: United Arab Emirates

In partnership with New York University Abu Dhabi's Shared Maritime Heritage on the Historic and Arabian Trade Routes programme that brings together students and experts from across the globe, CIE has supported training and research at community and academic levels. Through this partnership, as part of a broad maritime archaeology/heritage/survey programme, students are provided with heritage management training and archaeological expertise in line with the tenets of the 2001 UNESCO Convention on the Protection of Underwater Cultural Heritage and other UNESCO accredited training curricula.

The programme directly promotes the 2001 Convention as a framework for management and promotion of underwater cultural heritage in the home countries of students. In those instances where home states have already ratified the Convention, students are encouraged to lobby heritage management agencies, museums and academic institutions to further promote and implement the tenets of the Convention and to align national underwater cultural heritage strategies with the document. Where home states have not ratified, students are encouraged to lobby for ratification.

The programme creates capacity in underwater cultural heritage and management that is aligned with the 2001 Convention. On completion of the course, students will return to their home countries and are encouraged to conduct their research activities in line with the Convention and work with heritage management and government authorities to promote and implement practical programmes in line with the Rules in the Annex to the Convention.

As an accredited Nautical Archaeology Society (NAS) training partner, CIE has begun offering NAS training to a team of Emirati nationals and other key stakeholders with an interest in promoting UCH and the 2001 Convention and in developing local capacity. The team will establish and populate a database of UCH in the UAE in 2019.

3.2 Conferences, Workshops and Seminars

3.2.1 Regional Workshop on MUCH

In 2018 CIE worked with local partners on organizing a Regional Workshop on the Protection and Management of Maritime, Coastal and Underwater Cultural Heritage. Together with the NYUAD Institute and Dhakira Center for Heritage Studies at NYUAD, and in conjunction with UNESCO and ICCROM-ATHAR in Sharjah, CIE co-organized and hosted the 4-day UNESCO Workshop in January 2019 in Abu Dhabi and Sharjah. Experts from the Sharjah, Egypt, Morocco, the UK, Tunisia, Spain, Lebanon and Italy, and national representatives of Algeria, Bahrain, Egypt, Jordan, Lebanon, Libya, Morocco, Oman, Syria, Tunisia, UAE and Qatar participated in the activities. Experts and academics from NYUAD and the Abu Dhabi Department of Culture and Tourism led presentations that showcased research potential in the UAE and MENA region. NYUAD students, faculty and staff attended the conference thereby raising both national and international awareness of underwater cultural heritage and adding to intellectual capacity. The conference established a framework for regional cooperation in research and training and established a platform for data and resource sharing.

3.2.2. Meetings of the Accredited NGOs to the 2001 UNESCO Convention on the Protection of Underwater Cultural Heritage

In May 2018, CIE, in collaboration with ICOMOS-ICUCH and the Maritime Archaeological Trust, initiated and organized the first formal meetings of NGOs accredited by UNESCO and States Parties to the 2001 Convention. CIE chaired a session, Adoption of Recommendations, and was Secretary for the meeting. The meeting was organized to formulate two mechanisms to strengthen the voice and status of the NGOs. Firstly, the meeting aimed to

define the role of the NGOs in the promotion and implementation of the 2001 Convention. This included the promotion of the skills and capacity of NGOs in supporting the UNESCO Secretariat and States Parties to the Convention. Secondly, the meeting examined the structures for cooperation between international NGOs to further UNESCO's goals for the protection of underwater cultural heritage, to build capacity in underwater archaeology and underwater cultural heritage management and promote the 2001 Convention best standards through NGO programs, and to support initiatives of the UN International Decade of Ocean Science.

CIE and partners coordinate a follow-up meeting in December 2018 to report back on activities and assess progress.

3.2.3. ICAS 11

CIE, in partnership with NYUAD, hosted and chaired the panel *Sail/Canvas/Screen: Heritage Preservation and Recovery across Geographies and Media*, at the 11th International Convention of Asian Scholars (ICAS) held at Leiden University in July 2019. This panel brought together researchers who examine culture, design, and art in Indian Oceanic settings with an aim to explore how research-practices undergird heritage-preservation, the recovery of (lost) histories, and the circulation of knowledge. Crossing the terrain of pedagogy, aesthetics, and community engagement, the researchers are equally invested in thinking about flows of culture and knowledge that link the past and present, traversing seemingly diverse geographies. In this, the panel queried how research in art, design, and culture functions as a tool in the settings of the classroom, the art gallery, and in public spaces to disseminate knowledge and spur community dialogue.

3.3 Heritage network activities

3.3.1 Mozambique Island

As part of CIE's continuing Historic and Arabian Trade Routes Project, researchers Veronica Mateus Pereira and Claire Louise Okatch carried out fieldwork at Island of Mozambique (*Ilha de Moçambique*), Mozambique, in November 2018. Activities involved a combination of site visits, interviews, an exhibition and meetings with both local leaders and youth. The project supports CIE's goals to identify, capacitate and collaborate with local heritage stakeholders and to contribute towards research output in a context where CIE's Fragmented Landscapes of Heritage Narratives research framework is permanently tested.

Researchers worked together with a group of young volunteers through the intermediation of Hafiz Jamu, local leader and founder of the Mozambique Island Foundation, one of CIE's local partners.

Research outputs included the formation a Youth Heritage Group that brings together young people from across CIE's research sites. It is envisaged that as this group expands, they will collectively promote the role of youth as ambassadors for heritage.

At Mozambique Island, youth volunteers collaborated with the researchers to launch the Ofikiri Exhibition. "Ofikiri" is a *macua* word for *Reflections*. Exhibition content drew on narratives gathered during research conducted in 2017 and was expanded during the current period and was modelled on similar concepts applied to CIE's other research sites. The exhibition panels were displayed on a main street the *macuti* area of the island. The exhibition received a positive reaction and enjoyed great attention and curiosity.

At its conclusion, the project had established an extended group of young adults, some representing local associations, who will continue to survey islander's needs and ideas. The expanded network offered opportunities to expand the research area to include the buffer

zone surrounding the Mozambique Island World Heritage Site – *Cabaceira Pequena* – resulting in the emergence of new themes and problematics which can be explored in future field research.

Video profiles of the volunteers were collected.

Mozambique Island continues to show itself as a rich case study with a community willing to participate in heritage activities.

3.3.3 Dalma Island Survey

In partnership with the Dhakira Center for Heritage Studies at NYUAD, CIE led a team of historians, archaeologists, designers, engineers, students and divers to map sites and narratives related to the Dalma Island cultural landscape. The project was divided into three phases. Phase one utilized a local researcher to collect oral histories of Island residents. In phase two, a drone was used to create 3D photogrammetric models of three historical mosques, the Dalma Island historic harbour and the house belonging to a pearl trader which is now the Dalma Island Museum. In the final phase, researchers began mapping the historic pearl oyster bed that lies in shallow water at the southern end of Dalma Island.
